International Post and the GST

- Unless indicated otherwise, International Post charges are GST-free.
- A range of specially designed GST-free stamps is available for international mail.
- If you use a franking machine or postage meter to apply postage to international mail, you are required to apply postage at 10% above the card rate to offset input credits you may claim.
- If you wish to use domestic stamps on international mail, then you are required to affix postage at 10% above the rate shown in this Guide.

Insurance

Available for EMS International Courier and, for some countries, Letters and Parcels

Insured Value: Limit \$5000

Fee: **\$5.00** plus **\$2.00** per \$100, or part thereof, up to \$5000 (in some countries a limit lower than \$5000 applies)

Delivery Confirmation

Fee: **\$2.50** per article plus postage (Available with Registered Post, Insurance and, for some countries, Parcels)

Western Union International Money Orders

For USA payments **only**. Must be banked by payee - cannot be cashed at banks or POs.

Fee: **\$8.65*** (GST inclusive) per money order. Max. \$US1000

*Plus 10c State stamp duty in WA.

Demurrage

Fee: \$3.00 per item for each 24 hours over 96 hours (GST inclusive), for commercial articles stored at gateway mail facilities only.

The documentation required depends on the service used and the contents of the article, as detailed below.

Letters and Postage Prepaid Products are divided into two zones
Asia/Pacific (AP) & Rest of the World (RW)
 Parcels are divided into zones:
NZ, 1, 2, 3, 4 & 5

The following table classifies places into charging zones for FaxPost, EMS International Courier, Air Mail, Economy Air (Econ) and Sea Mail, and indicates availability of the various services. The maximum weight accepted by each country for each service is also shown. Note: For charging purposes, the following places are regarded as being within Australia: Christmas Island (Indian Ocean) and Cocos (Keeling) Islands - Western Australia; the Australian Antarctic Territories - Tasmania; Norfolk Island - New South Wales.
